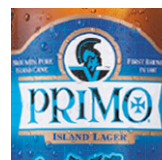

**RELEASE, WAIVER OF LIABILITY, INDEMNIFICATION  
AND ASSUMPTION OF RISK AGREEMENT**

In consideration of permission to use, today and on all future dates, the property, facilities, staff, equipment and services of the Outrigger Canoe Club, I hereby agree as follows:

**Release and Waiver of Liability:** I, for myself, my heirs, personal representatives, successors or assigns, do hereby release, waive, forever discharge, and covenant not to sue the Outrigger Canoe Club, its directors, officers, employees, and agents (collectively the "Releasees") from and against any and all disputes, demands, claims, damages, liabilities, actions, causes of action of any kind or nature whatsoever, whether in law or equity, arising out of or related to participation in competition, activities, classes, observation, and/or use of facilities, premises, or equipment of the Outrigger Canoe Club.

**Indemnification and Hold Harmless:** I also agree to defend, indemnify and hold the Releasees harmless from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees, brought as a result of my participation in any activities or competition at the Outrigger Canoe Club and to reimburse it for any such expenses or liability incurred.

**Assumption of Risk:** Physical activity, by its very nature, carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries.

The Outrigger Canoe Club has facilities for and provides for activities such as paddling, surfing, swimming, snorkeling, volleyball, classes and other sporting activities. Some of these involve strenuous exertions of strength using various muscle groups, some involve quick movements involving speed and change of direction, and others involve sustained physical activity which places stress on the cardiovascular system.

The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions 3) catastrophic injuries including paralysis and death.

I have read the previous paragraphs and I acknowledge, understand, and appreciate these and other risks that are inherent in the activities made possible by the activities, competition and services offered by the Outrigger Canoe Club. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

**Severability:** I further expressly agree that the foregoing agreements are intended to be as broad and inclusive as is permitted by the law of the State of Hawaii and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**Acknowledgment of Understanding:** I have read this Release, Waiver of Liability, Indemnification and Assumption of Risk Agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue the Outrigger Canoe Club, its directors, officers, employees and agents. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
